

Terms of Reference for a Feasibility Study on implementing capacity buildingSANT'EGIDIOactivities aimed at strengthening residents' registration and treatment of infectionsand non-communicable diseases (NCDs) in health centres in Mozambique

## 1. Background

## 1.1. Context

The promotion of human rights as the right to legal identity and the right to health in Sub-Saharan Africa is fundamental both to reduce the vulnerability of poor populations and to build the capacity of public, church and civil society structures. Gemeinschaft Sant'Egidio e.V., a German NGO in the network of the international Community of Sant'Egidio, has been working for years with various local partners in Mozambique to improve access to adequate health care, especially for people living with HIV (DREAM) and legal identity (BRAVO!) for the poor population in certain regions of Mozambique.

## Right to legal identity:

The right to legal identity is well rooted in the human rights agenda and is stated by the 1989 UN Convention on the Rights of the Child (art. 7 and 8). In Mozambique at national level, the vital events registration is governed by the Constitution, by the Civil Registry Code, reformed in 2018, and by the Family Law, reformed in 2019. Mozambique has also ratified the International Convention on the Rights of the Child (1989) and is a signatory of the African Charter of the Rights and Welfare of the Child (1990). According to Mozambique DHS 2011 about 47,9% of children under age 5 were registered, of which 28% have a birth certificate and 20% have no proof of their identity. The Human Development Report 2019 for Mozambique estimates at 55% the percentage for SDG 16.9 (percentage of children under age 5 who were registered). In March 2019, the implementation of the new digital system Sistema Electronico do Registo Civil e Estatisticas Vitais (e-RCEV) started in some selected districts.

Since more than a decade, Sant'Egidio is collaborating in the BRAVO! Program with the government of Mozambique for the strengthening of the civil registration system. Project partners plan to support in in Mozambique the state authorities in the implementation of civil registration in maternities and other activities in Maputo and in Maputo Province. Linking civil registrations to the health system is key to achieve the goal of universal infant civil registration. Furthermore, civil registration offices located in health centers can considerably mitigate the impact of barriers to birth registrations.

# Right to health care:

The HIV prevalence among adults in Mozambique, estimated by UNAIDS at 12.4%, is among the highest in the world. Women, especially young ones, and minors are particularly affected by the HIV epidemic. For example, 15.2% of women (15-49 years), 7.1% of young women and 2.8% of young men are HIV positive. About 2.2 million people are HIV-positive, including 150,000 children up to 14 years and 1.3 million women. In 2019, approximately 51,000 people died as a result of HIV infection, including 8,200 children. 1,338,100 people living with HIV are receiving AIDS treatment, which is about 60% of those who need it due to their AIDS (ART coverage). The introduction of various interventions against HIV, especially AIDS therapy, led to a 17% reduction in new infections and a 20% reduction in mortality from AIDS since 2010 (Source: https://www.unaids.org/en/regionscountries/countries/mozambique). The challenge is to improve access to HIV testing and treatment, and to link activities against HIV with health services for other infections and non-communicable diseases.

# 1.2 About Gemeinschaft Sant'Egidio e.V.

The Community of Sant'Egidio was founded in Rome in 1968. It is recognised by the Vatican as a "Public Association of the Faithful". Communities of Sant'Egidio exist in over 70 countries.

Gemeinschaft Sant'Egidio e.V. (GSE) is a German non-governmental organisation based in Würzburg, which coordinates the social activities of the German Sant'Egidio groups in various German towns. The volunteer members are committed to children from socially deprived areas, in visiting services for senior citizens, for the homeless, people with disabilities and refugees. Gemeinschaft Sant'Egidio e.V. is recognised as a non-profit and charitable organisation and has been awarded the DZI donation seal.

Since the beginning of the 1990s, Sant'Egidio has been involved in development aid projects in Africa, especially in the HIV treatment programme DREAM and in strengthening the registration authorities (programme BRAVO!). Since 1991, Gemeinschaft Sant'Egidio e.V. has been implementing projects with financial support from BMZ and GIZ.

## 2. Purpose and Objectives of the assignment

The overall objective of the consultancy is to support GSE in developing a project on capacity building and advocacy strategies needed to strengthen both the right to health access and the right to legal identity for vulnerable people in Mozambique. The consultant will receive a concept of the project "Capacity building of health and registration services in Maputo and Maputo Province" at the beginning of the assignement.

The study will provide GSE with a well-founded basis for the elaboration and optimisation of the project concept by clarifying prerequisites, opportunities and risks. This will assist GSE to achieve the project objectives and targets under the existing framework conditions.

## 3. Key tasks

The consultant will prepare a feasibility study which is no longer than 30 pages, to support GSE in planning the above project. Close consultation with GSE at every step is required. The feasibility study will be used by GSE and other relevant staff as well as designated implementing partners. The structure of the feasibility study should be:

Methods, tools, resources and procedures for data collection and analysis. Actors involved in the information collection process

3.3 Initial situation and problem analysis (at macro, meso, micro level):

 Develop an inception report, including relevant base-line-data and a time line covering phases and processes of implementation

Conduct a research and an in-depth analysis taking into account the contexts at macro, meso and micro level, including but not limited to:

- Current context in the following areas: Maputo City, Maputo Province and Nampula Province
- The potential of these areas in terms of both training new health staff in order to guarantee the right to health and free treatment, and of guaranteeing the right to legal identity trough the birth registration of new-borns
- National priorities for the sector

3.4 Project partner in the partner country (local partner)

- Activities and potentials of the project partner and other implementing partners with view to possible synergies and status of the NGOs network in the two countries
- Measures to strengthen the organization and capacity of the local partner
- Ownership of the local implementing partners
- Relationship of local partners to the target group and other actors (legitimacy

3.5 Target groups and other actors (at micro, meso and macro level)

- Elaborate a detailed target group analysis, including but not limited to:
- Number and type of beneficiaries (with specifics for the two areas and the two programmes)
- Specific needs of the target groups
- Role of the target groups in the social context,
- Possible conflicts of interest and potentials of the target groups

Elaborate a detailed stakeholder institutional analysis, including but not limited to:

- Governmental and non-governmental actors at the project site, in the planned project region, the project country
- Relationship to the government's development strategy
- Interests, conflicts of interest, interactions with other projects
- Support and influence potential of the different actors for the project
- Review of the agreements and Memorandum of understanding with the relevant state authorities

### 4. Methods and tools

- The consultant should do the assessment of the planned project according to OECD DAC criteria (http://www.oecd.org/dac/evaluation/49756382.pdf)
- The feasibility study should consider regarding the contexts, problems, target groups and stakeholders the macro, meso, micro levels
- GSE and the local partner will provide relevant documents, statistics, MoUs etc.

The process of preparing the feasibility study should be participatory and in consultation with GSE.

#### 5. Expected Deliverables

The consultant should submit the following key deliverables:

- Inception report
- Regular updates on the implementation status of the consultancy
- Draft report, to be submitted to GSE for feedback and comments
- Final report, based on tasks 2-10 as mentioned above, not later than two weeks after reception of comments on the draft report, written in English and not longer than 30 pages

#### 6. Qualification

The consultant has to have an experience of more than five years related with the assignment. Required qualifications are:

- University degree in the relevant field (development studies, politics, law, economics, children's rights, human rights, public health etc.)
- Demonstrate experience of having undertaken similar assignments
- Knowledge of the Mozambique governance and cultural context
- Demonstrated experience to facilitate the development process of an advocacy strategy and of human rights based projects
- Excellent written and verbal communication and reporting skills in English
- Strong analytical and drafting skills
- Good analytical and documentation/policy papers writing skills
- Good communication and facilitation skills

### 8. Time Table of the consultancy/Duration of task completion8

The timeframe for the feasibility study is estimated at 8 weeks, starting from the agreement contract sign-off date and ending when the final feasibility study report has been formally approved.

The assignment is expected to commence by march 2021 and to be completed by may 2021.

#### 9. Financial procedures

The payment will be made as follows: 1st instalment – 40% (after signing the agreement); and Final instalment – 60% (after submission of final deliverable

## 10. Ethics and child protection

The consultant is obliged to respect the following ethical and child protection requirements:

- Fair and inclusive: The consultant should seek the views of various stakeholders: Children with and without disabilities, street children, youth, their families, CSOs, community, partners and government actors and be able to identify and address potential conflict of interest and unequal power relationships. Special efforts should be made to make the research process child-centred and sensitive to gender and inclusion.
- Conflict of interest: The consultant must demonstrate the necessary independence and declare any conflict of
  interest and potential biases, including bias towards any of the stakeholders, target groups, types of research
  methodologies or approach, social, political or religious prejudice.
- Based on rights and ethics: The consultant must respect the rights and dignity of participants as well as comply with relevant ethical standards and Gemeinschaft Sant'Egidio e.V. Child Protection Policy and Ethical Code of Conduct. The research must ensure: appropriate, safe, non-discriminatory participation; a process of free and un-coerced consent and withdrawal and confidentiality and anonymity of participants. The informed consent of each person (including children) participating in data collection should be documented.
